Please read the following legal information located on the following two pages carefully before signing this agreement.

1. The Owner agrees that payment is due at the time of check out. Your cat will not leave House Cat Hotel until all charges are paid in full.
2. If your cat(s) is (are) not picked-up within 15 days after the date arranged, and after repeated attempts to contact the owner, the cat(s) shall be deemed abandoned, and at any time thereafter, House Cat Hotel may take whatever action it deems appropriate, including without limitation to, the placing of the cat(s) for adoption with another person.
3. The Owner is solely responsible for any and all acts or behavior of their cat(s). Owner will, to the fullest extent permitted by law, protect, indemnify and hold free and harmless House Cat Hotel from and against, any and all demands, claims, causes of action, fines, penalties, damages, liabilities, judgments, and expenses incurred in connection with or arising from the Owner's cat(s), including but not limited to bodily injury of persons, death of persons or property damage. If any action or proceeding is brought against House Cat Hotel by reason of any such claim for which Owner has agreed to indemnify House Cat Hotel, Owner, upon written notice from House Cat Hotel, will defend the same at Owner's expense, with counsel reasonably satisfactory to the Owner.
4. The Owner is fully responsible for any cost and charges, including without limitation, reasonable attorney's fees and collection costs incurred by House Cat Hotel in connection with any interpretation, defense or enforcement of any matter arising out of or in connection with your cat's boarding. It is expressly agreed that House Cat Hotel shall in no event be liable for any amounts claimed by you or anyone else in excess of the lesser of the value of a cat of the same species, or the total sum of \$200.00 for all cats boarded by you or anyone on your behalf.
5. If your cat becomes ill or if the state of the animal's health otherwise requires professional attention, House Cat Hotel, in its sole discretion, may engage the services of a veterinarian, administer medicine, or give other requisite attention to the animal, and the expenses thereof shall be paid by the Owner.
6. Any controversy or claim arising out of, or relating to this contract, or the breach thereof, or as the result of any claim or controversy involving the alleged negligence by any party to this contract or the breach, or as the result of any claim or controversy involving the alleged negligence by any party to this contract, shall be settled in accordance with the rules of the American Arbitration Association and judgment upon the award rendered by an arbitrator may be entered in any Court having jurisdiction thereof. The arbitrator shall, as part of his award, determine an award to the prevailing party of the cost of such arbitration and reasonable attorney's fees of the prevailing party.

7. Owner understands that if they select the webcam option during their cats stay, they must have access to a computer where the webcam viewing application can be downloaded and installed. House Cat Hotel is not responsible for situations where the Owner may not have access to a compatible computer or internet access.
8. By signing this Contract and leaving your cat with House Cat Hotel, the Owner certifies the accuracy of all information given.
9. This Contract contains the entire agreement between the parties. All terms and conditions of the Contract shall be binding on the heirs, administrators, personal representatives and assigns of the Owner and House Cat Hotel.
